

Declaration of performance

Plasmor Ltd has robust systems and supporting evidence in place to ensure its obligations under the Construction Products Regulation are fully met, which is required when placing product on the GB market. Our systems and supporting evidence are fully audited, both internally and also externally through a UK Approved body. Information relating to our factory production controls can be found on the delivered product and this is further supported by our product Declaration of Performance (DoP).

Plasmor have generated a list of DoPs to support the products placed on the market for their intended uses. Any product sold with the document text “seconds” is a non-conforming product that does not meet the criteria set out in the standards.

Product DoPs are available from your supplier, on the Plasmor Website or by contacting our Technical Department.

How to use this guide

1. Identify the product type, by either:
 - 1.1 Strapping – on either the vertical or horizontal strapping there is a printed website followed by a trade name and strength (i.e. Fibolite 3.6N)
 - 1.2 Delivery Ticket on direct to site loads from Plasmor – Each delivery ticket will quote the product (i.e. Fibolite 3.6N)
 - 1.3 Merchant – If the merchant delivers direct from the yard, this information should be supplied, however look on the strapping / delivery note for the information, if in doubt ask the supplier
2. Identify physically if the blocks are of solid or hollow format.
3. Go to [Plasmor.co.uk/CE](https://www.plasmor.co.uk/CE), the information above tells us that the product category for the DoP (declaration of performance) (i.e. 003 Fibolite 3.6N/mm²)
